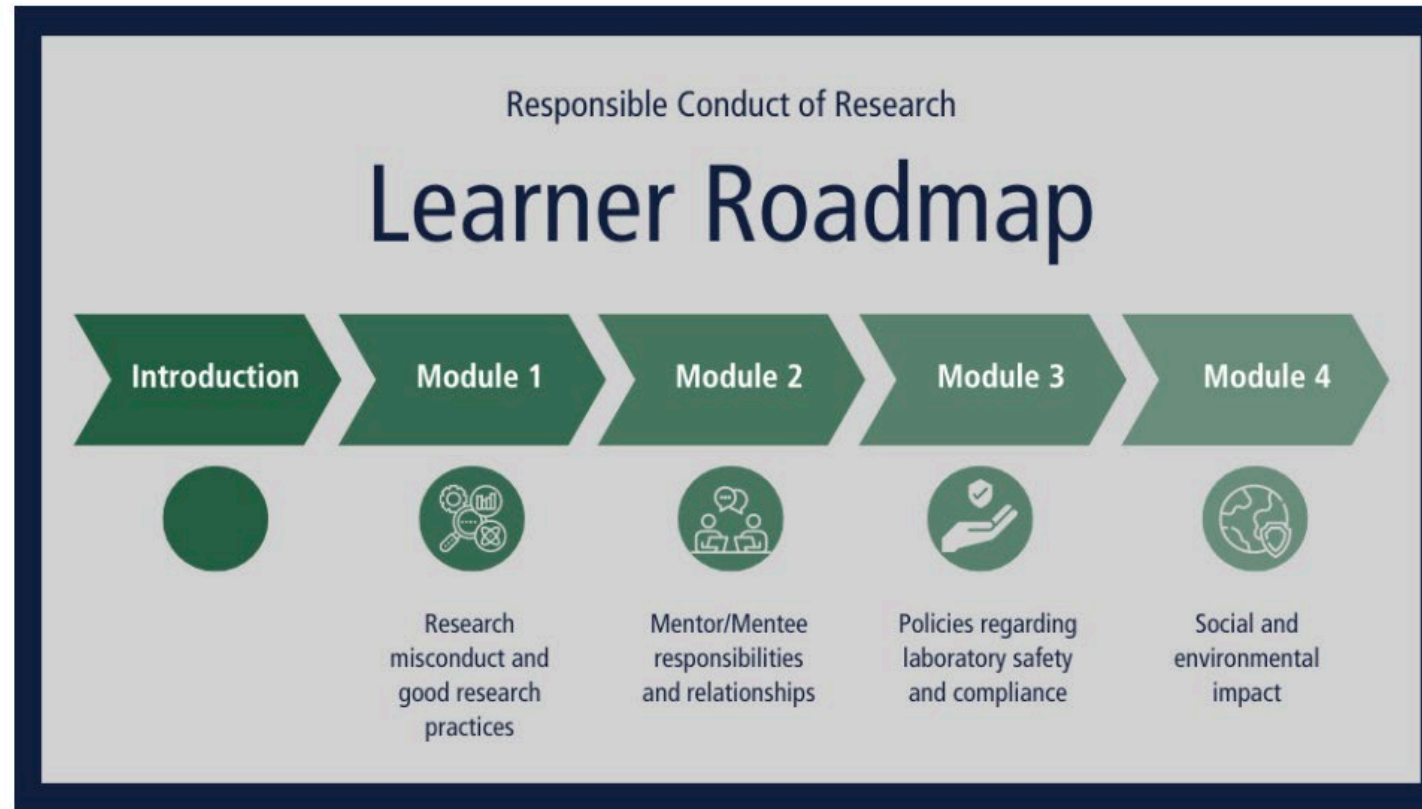

Advanced Accounts: When to Request & What is the Risk

Why Advance Accounts are a good idea:

- Eliminate cost transfers and PAAs
- Clear compliance and COI
- Reduce account setup delays

When not to request Advance Accounts:

- Clinical trials
- No clear start date and 90 pre-award not allowed
- Challenges with contract negotiation/new sponsor



Advanced Accounts: When to Request & What is the Risk

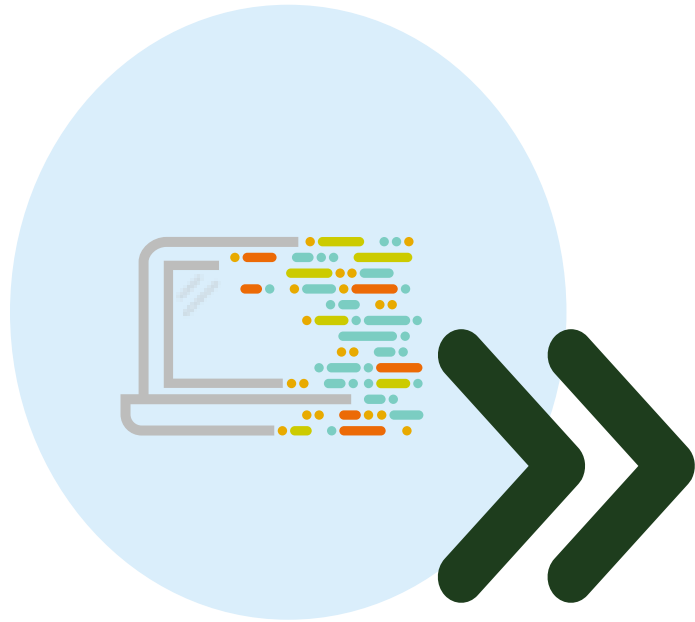
What are the risks

- Department responsible for all unallowable costs
 - Costs prior to start date
 - All costs if award not received
 - Costs determined unallowable by sponsor

Best practices and reminders

- Be very careful about spending beyond what you would have incurred on a PG
- Advanced accounts take the same amount of time as regular accounts as they go through the same compliance review
- Departments bear full responsibility for advance accounts





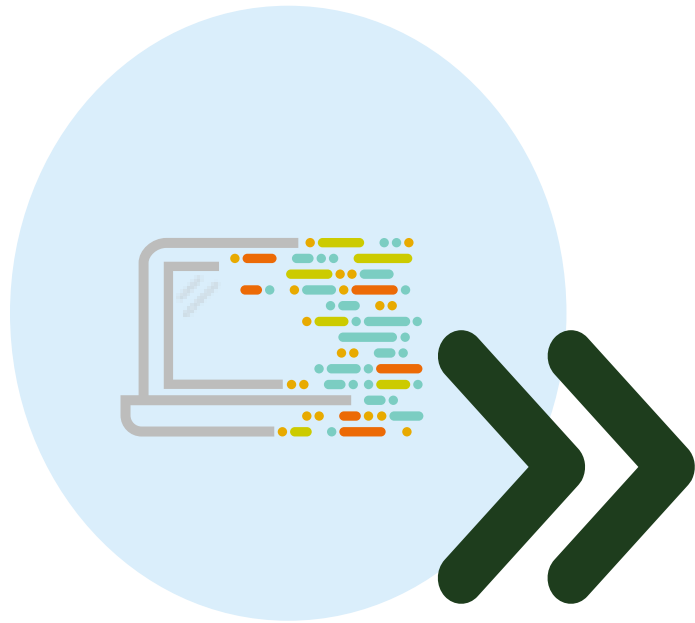

- ORA ensures that the submission of RPPR will occur within 3 days upon receipt.
- To ensure timely submission, please submit your RPPR at least 3 days before the deadline.
- There are no exceptions or alternatives available for the submission process



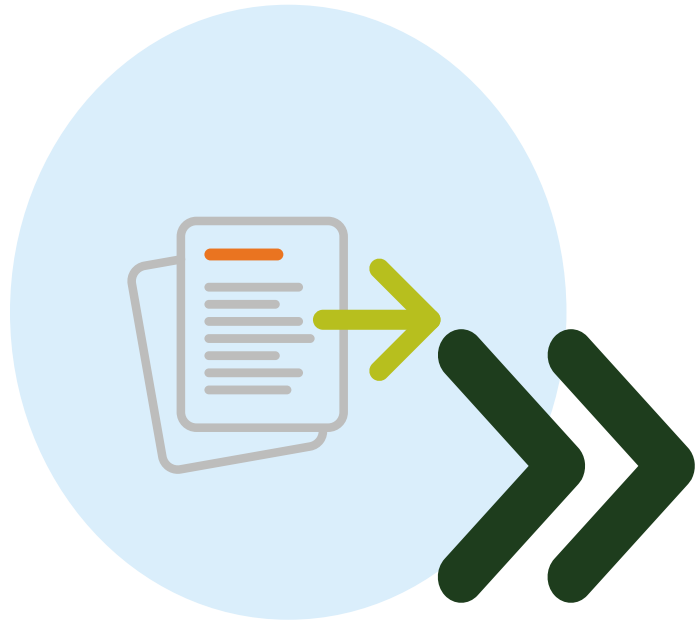

MCA In The Agreement Tab

- The effective date of implementation is June 5th.
- This new policy will ensure consistency across all projects that require a MCA.
- The process for submitting Clinical Trial Agreements to ORA will remain unaffected by this change.
- To access MCA and budget details, it will be necessary to refer to the associated object.

NSF Biographical Sketch and Current and Pending

- NSF requires a biographical sketch for each individual identified as senior personnel. See [PAPPG Chapter II.D.2.h\(i\)](#) for complete coverage on the content and formatting requirements for the biographical sketch
- » I Refer to [PAPPG II.D.2.h\(i\)](#) for the full biographical sketch requirements. A brief outline of the information you will need to include is provided below.
 - » Identifying information.
 - » Organization and location.
 - » Professional preparation.
 - » Appointments and positions.
 - » Products.
 - » Synergistic activities.
- » SciENCv *strongly encouraged now; required beginning October 23, 2023*

NSF Biographical Sketch and Current and Pending

PAPPG (NSF 23-1) Revisions: Biographical Sketch and Current and Pending (Other) Support

- Certification Requirements
 - Senior personnel must certify that the information is accurate, current and complete.
 - In SciENCv the certification is completed upon download of the document. The certification and timestamp is included on the PDF.
 - For the fillable forms, the senior personnel must type their name and date in the form. The certification is printed on the form.

NSF Biographical Sketch and Current and Pending

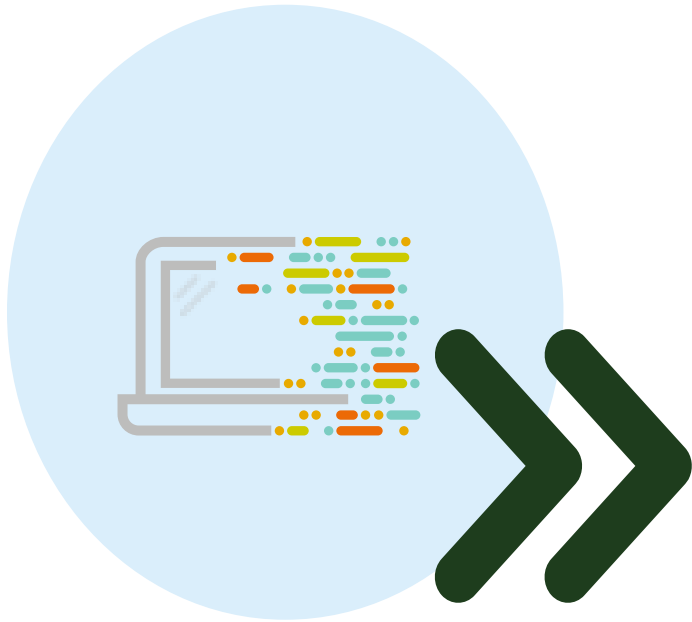


- Proposal Submission
 - Collaborators and Other Affiliations, Biographical Sketch, and Current and Pending (Other) Support must be submitted.
- Pre-Award
 - Updated Current and Pending (Other) Support may be requested by the NSF program officer and must be submitted for senior personnel before an award can be made.
- Post-Award
 - If the AOR discovers that a disclosure should have been submitted at the time of proposal submission, but was not, they have 30 days to submit a post-award request to NSF.
- Project Reports
 - PIs and co-PIs must specify whether new, active other support has been received in their annual and final project reports. If yes, they must include updated Current and Pending (Other) Support information.

NSF Disclosure Requirement

- *Proposal & Award Policies & Procedures Guide (PAPPG) (NSF 23-1)*
- Effective for proposals submitted on or after January 30, 2023
- Must disclose venture or other capital financings
- Qualtrics survey will be completed by all investigators submitting NSF proposals
 - Y/N responses
 - No identifying information will be collected
- RA has access to a spreadsheet listing names of the 147 investigators who have completed the survey
- If not completed:
 - NSF proposal cannot be submitted
 - funds cannot be released

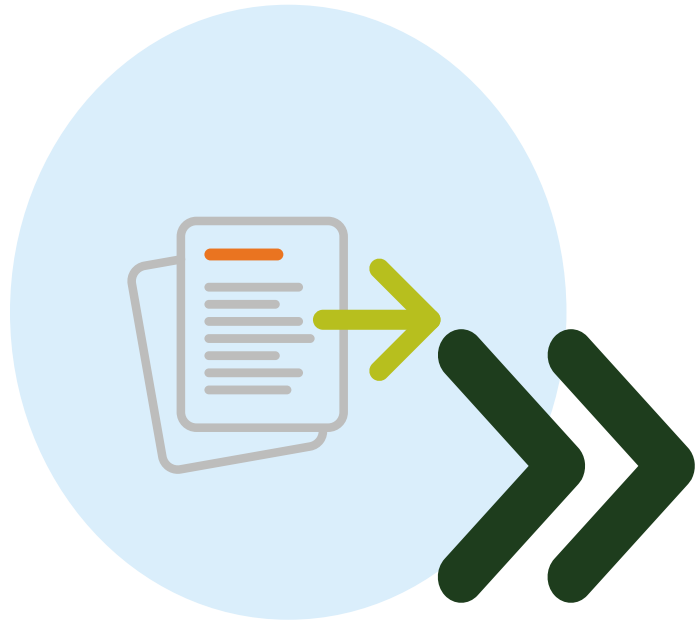

Monitoring Payments and Spending at Risk

- » Department staff and PIs should monitor any payment issues of which they have become aware (typically notified when Post-Award initiates collections efforts) and minimize spending until such issues are resolved.
- » In accordance with UM's Invoicing & Financial Reporting Policy, PIs must also notify ORA immediately if a sponsor has not accepted a deliverable and will not authorize the release of funds to satisfy a deliverable-based invoice.
- » If spending at risk—with or without an approved advance account—and notified by ORA of significant contractual negotiation challenges, Department staff and PIs should minimize spending until contractual issues are resolved.

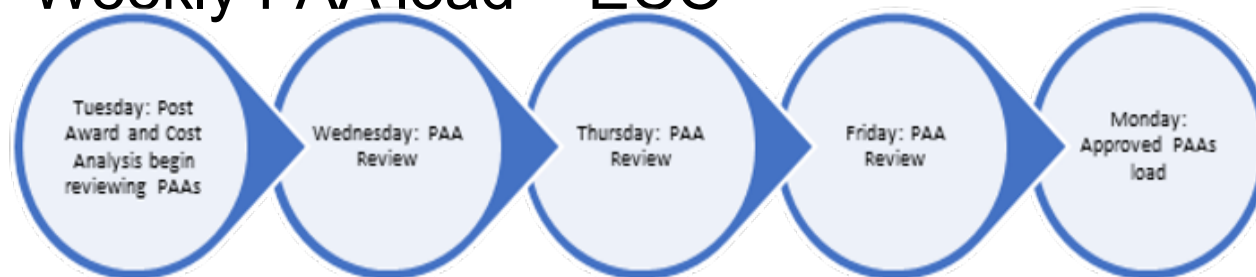

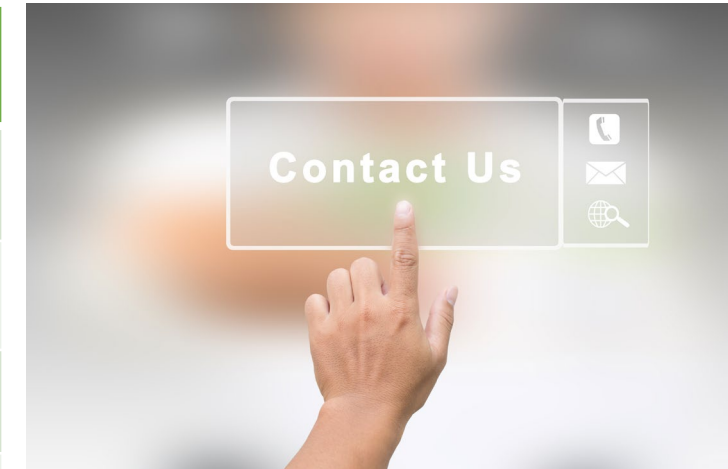

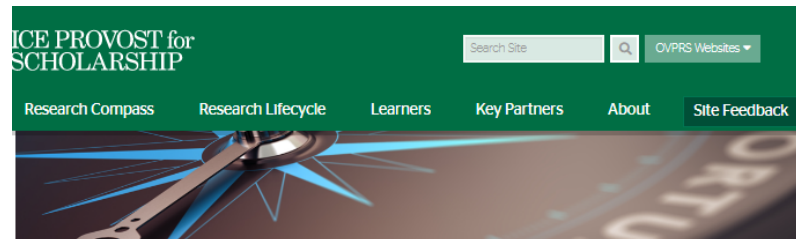

Tools for finding funding and collaborators.

The University provides access to global databases for research administration and funding opportunities. The Office of the Vice Provost for Research & Scholarship also collects proposals for limited submissions (opportunities for which only one team per institution can apply).



PIVOT

Pivot is the most comprehensive and trusted source for global funding information. It saves searches and tracks opportunities, and allows you to discover collaborators and get tailored funding recommendations and alerts.



LIMITED SUBMISSION COMPETITIONS

Limited Submission Applications are funding opportunities for which an external agency limits the number of proposals an institution may submit.
